Residential Energy Efficiency Program APPLICATION FOR REBATE

Subject to availability of funds, rebates are available toward the purchase and installation of high efficiency gas heating equipment (furnaces or boilers) in one to four-family houses. Commercial customers do not pay the System Benefits Charge and are not eligible to apply for these rebates. Customers receiving rebates/ financial inducements from NYSERDA for the same equipment are not eligible for a duplicate rebate under this program.

Qualifying equipment must be installed **on or after July 1, 2009** and must meet the minimum efficiency requirements of the program. **Furnaces with an AFUE rating of 90% or higher and boilers with an AFUE of 85% or higher will qualify.** A \$25 rebate is also available for the sale and installation of a programmable thermostat at the same time as the heating equipment installation.
